#### THE ORGANISATION OF AFRICAN, CARIBBEAN AND PACIFIC STATES



The Organisation of African, Caribbean and Pacific States (OACPS) is an organisation created by th-e Georgetown Agreement in 1975. It is composed of African, Caribbean and Pacific States which are signatories to the Georgetown Agreement or the Partnership Agreement between the OACPS and the European Union, officially called the "ACP-EC Partnership Agreement" or the "Cotonou Agreement". The main goals of the OACPS are:

- sustainable development of its Member States and their gradual integration into the global economy, which entails making poverty
  reduction a matter of priority and establishing a new, fairer, and more equitable world order;
- coordination of the activities of the OACPS in the framework of the implementation of ACP-EC Partnership Agreements;
- consolidation of unity and solidarity among ACP States, as well as understanding among their peoples; and,
- establishment and consolidation of peace and stability in a free and democratic society.



The Government and People of St. Vincent and the Grenadines recognizes the life and legacy of the late Mr. Parnel Campbell QC, a former Deputy Prime Minister, Attorney General and Minister of Justice of St. Vincent and the Grenadines. He was a nation-building trailblazer who dedicated his adult life to the service of his country through his political activism, influence on constitutional reform, and his national public service television series "The Law and You". Mr. Campbell also served as a doctoral research student, a Lecturer in Law, and a Fellow of the Caribbean Law Institute.

In historical order, some of the highlights of Mr. Campbell's career pursuits and achievements are herein outlined. In January 1980, he became a private legal practitioner and in October 1985 he was awarded the Honour of the Commander of the Royal Victorian Order (C.V.O.) by her Majesty Queen Elizabeth II, in person. In that same year, in November, Mr. Campbell was appointed as a Senator and Deputy Speaker of the House of Assembly.

A Tribute to Mr. Parnel R Campbell, QC Former Deputy Prime Minister, Attorney General and Minister of Justice of St. Vincent and the Grenadines

From 1986 to 2002, Mr. Campbell served as the elected Chairman of the New Democratic Party, and during this time, in February 1987, he became an elected Member of Parliament. In May 1989, Mr. Campbell was the elected representative for the constituency of Central Kingstown. Notably, from May 1987 to September 1995, Mr. Campbell was the Attorney General and Minister of Justice and Information. As Attorney General, Mr. Campbell oversaw the completion and publication of the Revised Laws of St. Vincent and the Grenadines 1990, in eight volumes. His efforts led to the creation of the Family Court in 1992, and he also piloted, directly or indirectly, over 300 pieces of legis-

lation through Parliament between 1987 and 1995. From February 1994 to September 1995, he was the Deputy Prime Minister of St. Vincent and the Grenadines.

In a thrust to educate and empower Vincentians about the law, in May 1997, Mr. Campbell produced and presented a television series on national television entitled "The Law and You". The programme continued, on Mondays, until the time of his death with 997 programs being aired. This, along with his numerous portfolios paved the way for him to have been awarded the distinction of Legal Luminary by the St. Vincent and the Grenadines Bar Association. Subsequently, he served as the President of the St. Vincent and the Grenadines Bar Association from October 2001 to August 2003. In October 2002, he was appointed Queen's Counsel and in November 2002, he was appointed the Deputy Chairman of the Constitutional Review Commission. From September 2003 to December 2009, he was the Chairman of the Constitutional Review Commission.

During the last two decades of his life, Mr. Campbell was ordained as a Pastor in the Spiritual Baptist Archdiocese with the responsibility to the St. Elizabeth Spiritual Baptist's Cathedral from June 9, 2002. In 2018, after the death of His Excellency Patriarch Edmund John, Chancellor Pastor PR Campbell was appointed as the Senior Pastor to head the St. Elizabeth Spiritual Baptist Cathedral at Belmont, and in 2019, he was appointed Dean of the said Cathedral. He held those positions until the time of his death.

Mr. Campbell was married to Juliette Campbell for forty-seven years and leaves to mourn his six children: Denise Grant, Dr. Arusha Campbell-Chambers, Alpha Campbell, Bantu Campbell, Mandella Peters and Daniel Campbell, grandchildren, other relatives, and friends, as well as the people of St. Vincent and the Grenadines.

Mr. Parnel R. Campbell lived a full life, and a legacy that would forever be entrenched on the minds and hearts of Vincentians and the region. The Ministry of Foreign Affairs and Foreign Trade conveys best wishes to his family.

## **318 OECS Nationals Travel to Canada for Employment**

to assist farm workers with travel to Canada. This marks the 3rd chartered flight for 2021, since commercial flight cancellations between Canada and the Eastern Caribbean due to the COVID-19 pandemic.

The OECS Commission, through its Eastern Caribbean Liaison Service (ECLS), has defied all odds to continue expanding participation of OECS nationals in the Canada-Caribbean Seasonal Agricultural Workers Programme – with over 1000 OECS workers in 2020 contributing approximately EC\$37 million dollars in remittances among the OECS and with similar expectations for 2021, amid the travel limitations and health risks caused by the COVID-19 pandemic.

The 1st chartered flight, scheduled to depart St. Vincent and the Grena-  $\Rightarrow$ dines on April 9th was delayed due to the eruption of the La Soufriere volcano and the subsequent implementation of emergency security  $\rightarrow$ measures.

Despite these difficulties, the OECS Commission has since mobilised three (3) chartered flights to move 318 OECS nationals to Canada - including 152 workers from St. Vincent and the Grenadines, many of whom are from communities in the red or orange zones and have been staying in shelters since the volcanic eruption. It is worth noting that these workers, along with their fellow OECS counterparts, will soon be gainfully employed and able to support their families and communities - this is especially important to the ongoing relief and rebuilding efforts in St. Vincent and the Grenadines.

Once again, OECS farm workers have displayed resilience and courage as

On Thursday, May 13th, the OECS Commission facilitated the 3rd flight they venture back to Canada for employment in the provinces of Alberta, British Columbia, New Brunswick, Ontario, Quebec, and a new addition -Saskatchewan, where 2 women from the Commonwealth of Dominica will commence employment as the first OECS farm workers in that province.

> Strict COVID-19 'Health and Safety' protocols continue to be reinforced by the OECS Commission in close collaboration with Ministries of Labour, Ministries of Health and Canadian authorities, prior to the departure of the workers.

Some of the revised 2021 Health and Safety protocols are as follows:

- COVID-19 testing, within 72 hours prior to departure, so that test results can be presented on arrival in Canada;
- Workers provided with travel kits containing face masks and hand sanitiser;
- COVID-19 vaccinations administered to interested workers on arrival in Canada;
- $\rightarrow$ Workers to be guarantined for 14 days on arrival in Canada - WITH FULL PAY;
- Additional supplementary insurance to cover workers for all eventualities, including with COVID-19;
- Farm accommodations have been sanitised under the supervision of Canadian Health authorities and the ECLS; and
- Each farm has an appointed worker representative and is part of a WhatsApp group with the ECLS team in Canada with 24-hour hotline support.

## ALBA-TCP Delegation visited Saint Vincent and the Grenadines to coordinate humanitarian bridge

H. E. Raul LiCausi, Deputy Minister for the Caribbean of the Bolivarian Republic of Venezuela and Mr. Sacha Llorenti, General Secretary of Alba-TCP met with Prime Minister, Dr. The Hon. Ralph E. Gonsalves and other Government Officials including the Minister of Agriculture, Forestry and Fisheries, Hon. Saboto Caesar. The delegation's visit to St. Vincent was to coordinate and strengthen the humanitarian bridge activated by the member countries of this regional bloc of the Alba-TCP to assist the people affected by the eruption of La Soufrière volcano in early April. Following the eruptions of the La Soufrière volcano, more than 14,000 persons were displaced and well over 100million dollars in losses and damages were registered. The delegation also carried out an evaluation of the living conditions of the Sandy Bay area where there was the destruction of important farmlands and the loss of cattles.

The ALBA-TCP donated humanitarian aid to assist with the relief efforts which includes 280 tons of drinking water, 48 tons of supplies, bottled water, food, personal hygiene kits, 100 1-gallon water tanks and a base station for mobile communications, in addition to medicines and health personnel provided by the Republic of Cuba. Venezuela also delivered 20 tons of humanitarian aid, 68 doctors and experts in natural disasters, including 15 members of the Simón Bolívar Humanitarian Task Force, and a navy ship to transport aid from the Caribbean's allied countries.

The Government and People of St. Vincent and the Grenadines thanks the Bolivarian Republic of Venezuela and ALBA-TCP for providing the support to this country. The Government looks forward to continuous cooperation with our friends and diplomatic allies as we work to strengthen the Caribbean and Latin American region.



The Bolivarian Alliance for the Peoples of our America (or ALBA for short) was founded on the 14<sup>th</sup> of December 2004 when Presidents Hugo Chavez of Venezuela and Fidel Castro of Cuba signed protocols bringing the agreement into existence. In its own terms the ALBA is defined as an "integration platform" whose fundamental purpose is to achieve "integral development" for Latin America and the Caribbean through a process of integration inspired by the likes of Simon Bolivar and José Marti. Beyond a narrow focus upon trade which has tended to mark other regional agreements, the ALBA professes to be a "political, economic, and social alliance in defence of independence, self-determination and the identity of peoples comprising it" (ALBA-TCP 2010a). #### COMMUNIQUE OF SAINT VINCENT AND THE GRENADINES ON THE MILITARY AGGRESSION OF THE STATE OF ISRAEL AGAINST THE STATE OF PALESTINE

The Government of St. Vincent and the Grenadines strongly urges the Government of the State of Israel to cease its most recent military campaign against the State of Palestine. We condemn attacks against Palestinians in East Jerusalem and Gaza and unilateral actions of the Israeli authorities with respect to Palestinian land. Most recently, Israeli forces have attempted to remove Palestinians from Al-Haram Al-Sharif and Silwan neighborhoods; conducted air strikes on Gaza; and launched weaponised attacks on Palestinians worshipping at Al-Aqsa Mosque – all of which we strongly condemn. Moreover, St. Vincent and the Grenadines condemns the use of force against innocent Palestinians resulting, most recently, in injuries to hundreds and the death of over one hundred Palestinians, many of whom were children. We express our deepest condolences to the families of the victims and reaffirm our solidarity with the State of Palestine.

St. Vincent and the Grenadines stands steadfastly against any attempts to alter the character and status of the Holy City of Jerusalem, by force. The United Nations Security Council has "Affirm[ed] a vision of a region where two States, Israel and Palestine, live side by side within secure and recognized borders." The international community, in consistently reaffirming the two-state solution, has emphasized that the status of Jerusalem is a "final status" issue to be negotiated by the parties. This position has been reaffirmed in various agreements, including the Camp David Accords, the Oslo Accords, and the Roadmap for Peace proposed by the Quartet on the Middle East.

The United Nations Resolution of November 22 2017 stated that the General Assembly "Reiterates its determination that any actions taken by Israel, the occupying Power, to impose its laws, jurisdiction and administration on the Holy City of Jerusalem are illegal and therefore null and void and have no validity whatsoever, and calls upon Israel to immediately cease all such illegal and unilateral measures."<sup>1</sup>

St. Vincent and the Grenadines, as an elected member of the Security Council and as a Member State of the United Nations General Assembly, will continue to stand against these violations of United Nations Security Council and General Assembly resolutions. Conflict prevention demands that violations such as the ones we have witnessed against the Palestinian State over the past week do not go unchecked – impunity creates a climate of perpetual unease and unrest. We call on all parties with influence over the situation to urge Israel to stop its military aggression against the Palestinian people, and to fully respect their legitimate and fundamental claims to dignity, equality and human rights.

The Government of St. Vincent and the Grenadines also expresses sincere condolences to the families of the several people killed in Israel. We also welcome the diplomatic efforts of other States and parties to end this deadly siege, but more must be done. The Security Council must stand by its previous resolutions, uphold international law, the Fourth Geneva Convention and the UN Charter.

United Nations General Assembly Resolution A/ 72/L.11, 22 November 2017



Statement by Dr. The Hon. Ralph E. Gonsalves, Prime Minister and Minister of Foreign Affairs delivered at the UN Security Council virtual meeting on May 7,2021, New York on the theme: "Maintenance of International

"Maintenance of International Peace and Security: Upholding Multilateralism and the United Nationscentered International System"

Thank you Mr. President,

I thank the preceding speakers for their remarks; and commend China for convening this important debate. As a small country whose continued peaceful existence depends on the norms and principles of international law, and the multilateral system in which these tenets are enveloped, St. Vincent and the Grenadines places particular emphasis on today's discussion. This fundamental principle is applicable for all states - large and small in every part of the world. Commandist, bullying or threatening behaviour by any state in relation to another is antithetical to this precept and portends dangerous consequences for all.

Last September, we commemorated the 75th anniversary of this treasured institution. We celebrated, too, the many successes and achievements realised in our collective quest for peace and prosperity. Yet, there is still much more to be done and to be ever more focused, creative and relevant in these complex and challenging times.

The COVID-19 pandemic has laid bare the reality that a renewed multilateralism remains an urgent moral, political and existential imperative, under-girded by the UN Charter principles of sovereignty, territorial integrity, and political independence. Amidst the severe health, socioeconomic, political, and security implications of COVID-19, states are required to contend with: the ever-intensifying hazards of Climate Change, the continued spread of terrorism and organised crime, increased hunger and acute food insecurity, political polarisation, disinformation and hate speech, the escalation of ethnic and intercommunal tensions, and in far too many contexts, conflict and mass human displacement.

These contemporary challenges are inextricably inter-connected. And they will not be successfully addressed by any short-sighted unilateral or military means. To the extent that many of these issues stretch across borders, and more easily overwhelm the limited capacities of vulnerable states, effective and coordinated multilateral action is an essential condition for any sustainable solution. Only a comprehensive whole-of-system approach would suffice in addressing the peace and security, development, and humanitarian concerns of affected states.

Mr. President, In the face of vast but continually expanding peace and security challenges experienced globally, we must move quickly in a fresh direction. Bold and innovative steps are needed to alleviate human suffering, especially in conflict-affected settings. Capacity-building and development assistance should be scaled up, and national ownership over peace and political processes strengthened. Practical, inclusive, people-centered, and climate-sensitive solutions ought to be developed and implemented in line with national needs and priorities, and in accordance with the Sustainable Development Goals.

It is necessary and desirable that all states must work together, constructively and within the framework of international law - with the support and assistance of the United Nations and relevant regional and sub-regional organisations - to achieve this vision of a more peaceful and prosperous world. When disputes do occur, they ought to be settled amicably and equitably through dialogue, diplomacy, mediation, and other participatory approaches, rather than through unilateral or coercive means. There can be no substitute for trust and mutual respect. Any deviation from these universally accepted norms, wheresoever and by whomsoever committed, severely undermines the ideals of multilateralism embodied in the UN Charter. St. Vincent and the Grenadines remains committed to these guiding principles.

To conclude, Mr. President, let us all be reminded of our forebears' vision of unity and solidarity as they fashioned this United Nations system. As we seek to confront the unique and complex challenges of the 21st Century, including a sustainable recovery from the COVID- 19 pandemic which has already destroyed far too many lives and livelihoods, the extant circumstances demand the presence of a renewed and effective multilateralism steeped in the virtues of inclusivity, equality and justice, and guided by the principles of international law. We cannot remain separated by narrow interests or be divided in purpose. We must work in comity even more, together, urgently and resolutely, to realise peace, security and development for all of humanity. I Thank You.

## The Government of Mexico donates Ventilators and Humanitarian Aid to St. Vincent and the Grenadines



On June 2 2021a Mexican Air Force aircraft landed in St. Vincent and the Grenadines with two ventilators and humanitarian aid that were donated by the Government of the United Mexican States to the Government of St. Vincent and the Grenadines to assist the health care delivery and ongoing disaster relief efforts following the explosive eruptions of the La Soufrière Volcano. The Mexican delegation was headed by the Executive Director of the Mexican Agency of International Cooperation for Development (AMEXCID), Dr. Laura Elena Carrillo Cubillas.

A handing over ceremony for the donation of the ventilators and humanitarian aid was held at the Argyle International Airport. The Minister of State with responsibility for Foreign Affairs and Foreign Trade, Senator The Honourable Keisal Peters, the Honorary Consul of Mexico, Mr. Joel Providence, Representative from the Ministry of Health, Mrs. Neeka Anderson-Isaacs, Chief Executive Officer of the Argyle International Airport, Mrs. Corsel Robertson, and AIA Airport Staff were on hand to witness the official handing over of the donations which included: two (2) Mexican-made medical ventilators, 10,000 cans of tuna and 18,000 masks.

Minister Peters in her remarks reiterated the importance of bilateral relationships especially at a time like this when we need the assistance of our diplomatic allies. Minister Peters on behalf of the Government and People of St. Vincent and the Grenadines expressed much thanks and appreciation for the solidarity shown by the Mexican Government through the humanitarian aid that will assist with the relief and recovery efforts.

The explosive eruptions of the La Soufrière volcano which occurred, commenced on April 9, 2021 at approximately 8:41 a.m. resulted in significant damage to properties, loss of livelihoods and the evacuation and displacement of over twenty thousand Vincentians from the red and orange zones in St. Vincent and the Grenadines.

The SVG Consulate in Toronto, Canada under the auspices of Consul General Fitzgerald Huggins donated a container of new clothing items and face masks to be distributed to citizens of St. Vincent and the Grenadines affected by the eruption of the La Soufrière volcano.

The donation handed over on June 16, 2021 included a total of twenty-eight thousand (28,000) units of clothing for children and adults, kids toys and learning aids, makeup for female and shoes etc valued at Canadian \$1.5 million. This donation was made possible through the J2 Retail Management Inc; the registered Canadian charity that has provided disaster relief and life-saving humanitarian aid since 2002. GlobalMedic contributed a total of 1.5 million masks which include surgical masks, N95 masks, respirators and children masks. Both donations were made through the SVG Consulate in Toronto to assist in the recovery efforts for the displaced persons in

## Prime Minister Ralph Gonsalves of St Vincent and the Grenadines on Thursday, 24th June 2021 arrived in Venezuela to participate in the 19th ALBA-TCP Summit

In the context of the 19<sup>th</sup> ALBA-TCP Summit of Heads of State and Government of the Bolivarian Alliance for the Peoples of Our America-Peoples' Trade Treaty (ALBA-TCP), Prime Minister of St. Vincent and the Grenadines, Dr. The Hon. Ralph Gonsalves, arrived on Thursday, 24th June 2021 in the Bolivarian Republic of Venezuela.

Prime Minister Gonsalves was welcomed at the Simón Bolívar International Airport by Foreign Minister Jorge Arreaza, Foreign Vice-Minister for the Caribbean Raúl Li Causi, and ALBA-TCP Executive Secretary Sacha Llorenti.

The representative of the Caribbean nation attended the high-level summit of the regional bloc, that was held under the theme "Alliance for Life and Independence." The 19<sup>th</sup> ALBA-TCP Summit was convened to strengthen integration in the face of the challenges of the post-pandemic, and it will be held on the commemoration of the Bicentennial of the Battle of Carabobo.

The ALBA-TCP's mission is to strengthen fraternal relations among the Latin American and Caribbean people on the basis of solidarity, complementarity, justice and cooperation. In this context, on April 10, 2021, a Venezuela's navy ship *Armada AB Goajira T-63* set sail with 20 tons of humanitarian aid to support the Vincentian people as part of the "Simón Bolívar" Humanitarian Task Force following the eruption of *La Soufriére* volcano.

The shipment sent by Venezuela included drinking water, non-perishable food, blankets, sheets, mattresses, mosquito nets, hammocks and personal hygiene kits. The Venezuelan and Vincentian governments coordinated this solidarity-based action to face the challenges caused by nature as soon as the Caribbean nation decreed the state of alert.

St. Vincent and the Grenadines joined ALBA-TCP on June 24, 2009.

# Statement on the Assassination of the President of the Republic of Haiti, Jovenel Moise

On behalf of the government and people of St. Vincent and the Grenadines and on my own behalf, I convey sincere condolences to the family and friends of President Moïse and to the people of Haiti. I pray that God grants them all strength at this immensely difficult time. The government and people of St. Vincent and the Grenadines stand in solidarity with the people of Haiti in their grief.

The government and people of St. Vincent and the Grenadines reaffirm our commitment to ensuring that the Caribbean region remains a zone of peace and call for calm in the Republic of Haiti.

The people of Haiti are urged to refrain from vigilante justice and retaliatory aggression that can compromise the constitutional order in the Republic of Haiti.

## La Soufrière Volcano Features Again at OAS Meeting



Ms. Michelle Forbes, Director of the National Emergency Management Organization (NEMO), gave an overview of the aftermath of the 2021 La Soufrière volcanic eruptions at the annual Meeting on the Special Security Concerns of Small Island and Low-Lying Coastal Developing States of the Caribbean at the Organization of American States (OAS) which was held virtually on Thursday, July 1<sup>st</sup> 2021.

This year's theme "A Multidimensional Approach to Advancing Disaster Resilience in the Hemisphere/Caribbean" shed light on the multipronged approach to disaster management in the hemisphere. The Caribbean, due to its geographical location and geological structure, is the second most disaster prone region in the world, according to the United Nations Office for the Coordination of Humanitarian Affairs (OCHA). Disaster resilience takes into consideration this propensity for disasters and aims to build vulnerable communities, the capacity and capability to recover from disasters despite the existence of such vulnerabilities.

Representing St. Vincent and the Grenadines as well was Mrs. Dora James who offered a testimony from the perspective of the community. Mrs. James spoke on preparations, the evacuation exercise, clean-up efforts and moving forward.

Ms. Forbes stressed that clean-up efforts which will be long-term, are on-going and will be hampered by the Atlantic Hurricane Season, with the first approaching storm, Elsa, expected to make landfall on Friday, 2<sup>nd</sup> July 2021.

Ambassador Lou-Anne Gilchrist, Ambassador to the United States of America and Permanent Representative to the Organization of American States, expressed appreciation for the convocation of the meeting and reiterated gratitude for the support and solidarity from Member States following the devastating volcanic eruptions in St. Vincent and the Grenadines.

Other speakers were Ms. Tonya Ayow, Deputy Executive Director (Ag), The Caribbean Community Implementation Agency for Crime and Security (CARICOM IMPACS); Dr. Kirk Douglas, University of the West Indies (UWI), Cave Hill Campus and Mr. Dennis Marcelle from the Caribbean Disaster Emergency Management Agency (CDEMA).

Taken together, the speakers provided a comprehensive overview of the vulnerabilities and the Special Security Concerns of Small Island and Low-Lying Coastal Developing States of the Caribbean and focused on the need for multi-pronged responses to these concerns. The case of the volcanic eruptions in St. Vincent and the Grenadines was illustrative of the compounding impact of natural disasters and the COVID-19 pandemic and how onerous the ramifications can be.



Speech Delivered by Senator The Honourable Keisal M. Peters, Minister of State with Responsibility for Foreign Affairs and Foreign Trade, St. Vincent & the Grenadines At The OECS Meeting of Ministers of Trade, Agriculture and Fisheries 21.06.2021

Honourable Ministers; Director-General of the OECS Dr. Didacus Jules; Director Ms. Jacqueline Emmanuel Flood; Permanent Secretaries and other Senior Officials; Staff of the OECS Commission; Ladies and Gentlemen, good morning.

It gives me great pleasure to deliver these remarks and given the pressing nature of the World Trade Organization's (WTO) Fisheries Subsidies

Negotiations, please permit me to focus my reflections on this topic.

OECS Member States are very small players in the context of the overall global fishing industry. Data from the University of British Columbia reveal that between 1950 and 2016, OECS fishing fleets accounted for 0.013% of global total fish catch. This is certainly a microscopic sum.

Notwithstanding our miniscule contribution to global fish catch, the fishing industry is an important pillar of the socioeconomic landscape of the OECS. We rely on the sector for foreign exchange earnings, protein intake, employment and the economic wellbeing of many communities, especially rural and vulnerable communities.

In terms of economic diversification, several of our countries have also identified the fisheries sector as an impetus to this goal and with the inclusion of my own country, we have actively been seeking foreign direct investments in the sector, as well as building the capacity of local players to trade both locally and internationally.

Given these realities, the OECS certainly has a huge stake in the health and sustainability of our oceans. Therefore, we look on with dismay at global trends towards unsustainable, illegal and over fishing.

Since 1988, global fish stocks have been declining due to a combination of global warming, illegal fishing and overfishing. The Food and Agriculture Organization (FAO) notes that there is an increasing global trend towards biologically unsustainable fishing.

Of course, subsidies, especially subsidies provided by large fishing nations to large-scale industrial fishers, have also played an outsized role to the types of fishing efforts which are contributing to the depletion of our living marine resources.

In this context that the OECS has a systemic interest in securing a positive outcome in the WTO Fisheries Subsidies Negotiations. As you are well aware, these negotiations have been ongoing for the past 20 years and if we were to spend another 20 years negotiating, we will have very little, or no fisheries left.

Rather, a positive outcome for the OECS would be one which is faithful to the mandate in the negotiations which is to "prohibit certain forms of fisheries subsidies which contribute to overcapacity and overfishing, and eliminate subsidies that contribute to illegal, unreported and unregulated (IUU) fishing, and refrain from introducing new such subsidies." Importantly, the mandate in the negotiations also calls for "appropriate and effective special and differential treatment (SDT) for developing and least developed countries", which is seen as integral to a balanced outcome.

Allow me to say a few quick words on SDT. This is the bedrock of our participation in the multilateral trading system. We cannot imagine a final agreement on fisheries subsidies which does not allow us the policy space and the technical assistance and capacity building to develop the fisheries industry in a sustainable manner. It is important for us to send this signal to our CARICOM and ACP colleagues, as well as to the wider WTO membership, when the Ministerial meeting is convened next month.

We have no interest in using SDT to promote unsustainable practices, as I understand the narrative emerging from some sections of the WTO membership to be suggesting. Rather, we are not contributors to the global problem of overfishing and overcapacity and therefore, we must not be subject to the same obligations that the problem makers are required to contend with.

As I prepare to close, let me emphasise that this is crunch time for the fisheries subsidies negotiations. It might be now or never and we cannot live with never. We have to hold the line with respect to OECS, CARICOM and ACP solidarity. Where there is the possibility for compromise and flexibility in the negotiations, we must be prepared to demonstrate such without undermining our fundamental principles.

Finally, I look forward to our deliberations here today. The presence of Ministers with responsibility for both Trade and Fisheries is a demonstration of the cross-cutting nature of this sector. We do not meet often in this format and therefore, I invite us to take full advantage of this opportunity to share solutions as we prepare for a very intense few weeks ahead.

# Agriculture in the Eastern Caribbean

One Community · Growing Together

Transforming agriculture in the Eastern Caribbean is one of the priorities of the OECS. A review of the Policy Framework and Strategic Plan for Agriculture was conducted by the OECS Commission in 2009. The results of the review highlighted some of the key challenges of the agricultural sector in the OECS Member States including a growing population, an increase of food demand accompanied by changing dietary preferences, an increase of the cost of energy and a scarcity of resources such as water and land. The access to sustainable financial resources to ensure the production and distribution of food is also one of the main issues faced by stakeholders in the area of agriculture in the Eastern Caribbean.

In recognising the urgency to address these issues the OECS Commission, through the Agriculture Unit, is collaborating with its Member States along with multiple international agencies to review existing policies and formulate and execute a strategy for a sustainable development of agriculture in the Eastern Caribbean region.

6th July 2021



Excellencies, ladies and gentlemen, good day.

Mr. Chairman, thank you for the floor. It is past 4:00a.m. here in St. Vincent & the Grenadines, but the importance of this topic demanded my presence with you today. Like other small vulnerable economies (SVEs), St. Vincent and the Grenadines is unfortunately, almost a daily case study in vulnerability. Indeed, it is part of our lived existence.

Indeed, the ever-present threat of natural disasters has become part of our reality on an almost daily basis. It should therefore not be a surprise to you that my own preparations for today's dedicated session were interrupted by the passage of Tropical Storm Elsa which was subsequently upgraded to a hurricane. This had my country and the neighboring islands of Barbados, Grenada and St. Lucia on full lockdown. Sadly, Elsa has impacted on St. Vincent and the Grenadines, Saint Lucia and Barbados. The costs and destruction measured in both lives and infrastructure is still being assessed. I should also note that Elsa is the first hurricane to make landfall in Barbados for 65 years. Even as we had one eye on Hurricane Elsa, St. Vincent and the Grenadines was still dealing with the negative fallout of the COVID-19 pandemic as well as the ongoing volcanic eruption.

On 9<sup>th</sup> April, our volcano at *la Soufriere* erupted explosively, displacing 20,000 thousand and decimating important sectors such as agriculture, tourism and fishing. In the space of two weeks, there were over 30 explosive events, covering the entire island in volcanic ash. Neighboring islands such as Barbados and St. Lucia were also impacted, again, a reflection of our shared vulnerability. The explosive eruptions were followed by floods and fast-moving mudflows which dealt further devastation to the island in a very short space of time. These mudflows are likely to be a clear and present danger for the foreseeable future. The government's preliminary assessment estimates USD 20 million in *damage and loss* to general agriculture infrastructure, a huge sum for a small vulnerable economy. Damage to crops, livestock, forestry and fisheries are estimated at over USD 64 million. However, the full extent of the *damage and loss* will need to be comprehensively assessed and may result in much higher estimates.

While I am here in my capacity as a Minister of Government of St. Vincent and the Grenadines, I will also take the liberty of drawing on the experience of my fellow Organisation of Eastern Caribbean States (OECS) and Caribbean Community (CARICOM) Members.

You will recall that not so long ago, other SVEs in the Caribbean suffered severe devastation from hurricanes. In 2019, Dorian, a category 5 hurricane, caused mass destruction in parts of The Bahamas. In 2017, Hurricanes Irma and Maria, both category 5 hurricanes, made landfall in the Eastern Caribbean within two weeks of each other and caused about \$12 billion of damage to the OECS islands. Dominica and the island of Barbuda suffered the brunt of this carnage.

According to the Intergovernmental Panel on Climate Change (IPCC), climate change is expected to compound the problem by making such disasters more severe and frequent. It is projected that Global climate change will result in rising sea levels, changes in rain patterns and temperatures, and more intense hurricanes.

With most of the OECS population living in high-risk areas exposed to sea-level rise and weak infrastructure, and heavy reliance on climatesensitive sectors, the risks are expected to worsen through damage to biodiversity and coastal erosion risk to water and food security and increased health risks.

As the World Bank has noted, the OECS countries' small size contributes to natural disasters resulting in high losses relative to GDP, as when a disaster hits, virtually all economic activity lies in its path. According to UNICEF, the vulnerability of these islands is further shaped by socio-economic factors such as their reliance on climate-sensitive sectors, including tourism, agriculture and fisheries, limited resources, high levels of public debt, and environmental fragility.

According to the World Bank, natural disasters are estimated to have cost the OECS countries an average of 3.6 percent of GDP between 1997 and 2016, significantly above the average for all small states of 1.04 percent. Dominica and Grenada rank second and third globally, respectively, in terms of the relative amount of damages and losses over the past two decades, with an estimate at almost 8 percent of GDP.

Essentially, in the World Bank's assessment, natural disasters undermine our ability to attain macroeconomic and development goals and to break-free from the vicious cycle of low growth and high debt prevalent in the OECS region. Disasters also significantly impact countries' economic growth through eroding governments' fiscal buffers. Such events result in governments having to divert their attention and scarce resources away from vital longer-term development priorities, thereby placing tremendous financial pressure on OECS governments.

The high costs incurred by climate-induced events have also contributed to the region's high public debt. For example, the Government of St. Vincent and the Grenadines estimates that fifteen percent (15%) of debt accumulated between 2010 and 2017 is directly attributable to post-disaster reconstruction and investments in building disaster resilience.

You might be wondering what the trade policy nexus is in light of what I have said to date. Of course, I am also aware that not all WTO Members see a role for the organization in the context of the vulnerability of my country and other SVEs to natural disasters.

The most obvious and immediate nexus is that natural disasters severely affect the sectors on which we rely on to trade, notably agriculture, fisheries and tourism. Damage to trade support infrastructure, such as roads, ports and telecommunications, heighten trade costs and compound our ability to trade and access global supply chains post-disaster.

What then are the trade policy implications and options? Before I offer my own impressions, let me pose a few questions for our collective consideration:

First, there are the GATT General and Security Exceptions for instance. However, do they provide any flexibility to a Member who may want to invoke certain WTO inconsistent measures to rebuild from a natural disaster?

Second, what type of trade policy measures might a Member want to invoke which may be WTO inconsistent? Would that be to provide certain forms of specific subsidies, and in this regard, does the Agreement on Subsidies and Countervailing Measures (ASCM) provide any flexibility? Would it be to provide certain forms of domestic support and subsidies to agriculture and does the Agreement on Agriculture suffice? Would Members want any flexibility to increase tariffs beyond the bound rates to provide protection to a domestic sector? Would members want to apply discriminatory tariff rates among trading partners?

These are certainly worthy of further reflection. However, as you reflect, you may actually be able to draw some inspiration from the current draft of the Fisheries Subsidies Text which envisages a carve-out for disaster relief. Do we then move forward by adopting a similar approach in future WTO agreements? Or alternatively, do we create an omnibus WTO framework for disaster relief which applies to current and future WTO agreements? Unfortunately, I do not have a definitive answer, but put these ideas on the table for delegations to consider.

As I prepare to close, let me assure you that we are prepared to engage with Members on these important issues with a view to raising awareness of the impact natural disasters on our trade. We also remain open to discuss with Members, the appropriate trade policy responses that can be deployed in this context.

Mr. Chairman, the WTO must be actively engaged in these matters.

Finally, as a deliverable for MC12, we call on Members to support a Ministerial Decision of the Work Programme on Small Economies. We place a high degree of importance on such an outcome which must also recognise the vulnerability of countries like mine and many other SVEs to natural disasters.

#### STATEMENT ON CUBA'S REMARKABLE AND HEROIC REVOLUTION

The Cuban people, in affirming their right to pursue a socio-economic and political path of their choice, in their own interest and on their own terms, have been subjected relentlessly to an ongoing criminal destabilization, terror, sabotage, and harsh economic sanctions, inclusive of an economic blockade which was again recently denounced by an overwhelming majority of the United Nations General Assembly as contrary to international law — only two countries out of 193 voted in favour of this criminal and imperialist blockade.

In all this, we ought to be reminded that the Trump Administration in the USA tightened the embargo against Cuba with 243 specific measures which rolled back the partial easings under President Obama. The Trump measures are still

The government and people of St. Vincent and the Grenadines commend the Cuban Revolution on its extraordinary achievement of producing at least two vaccines in the fight against COVID-19 and on its selfless commitment to share these vaccines with the developing world on their approved roll-out.

## Her Excellency I. Rhonda King (C.B.S) Awarded Kenya's Chief in The First Class of the Order of The Burning Spear by President Uhuru Kenyatta

St. Vincent and the Grenadines' Permanent Representative (PR) to the United Nations, Her Excellency I. Rhonda King (C.B.S) was awarded Kenya's second highest national honour: First Class of The Order of the Burning Spear, by President Uhuru Kenyatta, in a ceremony held in Kenya on 23rd July 2021.

While The Order of the Burning Spear is given for distinguished services, the Chief of the Order of the Burning Spear (C.B.S) is reserved for principal public dignitaries, exemplary members of the public service and other professionals. Ambassador King (C.B.S) joins a distinguished list of outstanding individuals to have been designated C.B.S; a list which includes the famous 800 metres Olympic Champion and world record holder, David Rudisha. The only higher national honour in Kenya, Chief of the Order of the Golden Heart (C.G.H), is reserved for holders of presidential office.

The award was conferred during a diplomatic visit to Kenya, in which King, as Head of the SVG Mission to the United Nations, participated in a retreat as a





member of the A3+1 (Kenya, Niger, Tunisia, and St. Vincent and the Grenadines). The A3+1 is a formulation within the United Nations Security Council (UNSC) for cooperation among the three African countries and St. Vincent and the Grenadines. This cooperation is grounded in the principle of "African solutions for African challenges" and in recognition of the African diaspora as the sixth region of Africa.

During its campaign for a seat on the UNSC, St. Vincent and the Grenadines signalled its intention to function as a fourth seat on African issues, and as the voice of CARICOM and GRULAC. ## SVG DISCUSS FUTURE PROSPECTS WITH WORLD CENTRAL KITCHEN



Following the eruption of the La Soufrière volcano on the 9th April, 2021, the World Central Kitchen (WCK) reached out to the government of St. Vincent and the Grenadines to offer assistance with disaster response.

Upon arrival, WCK activated its Emergency Food Relief Programme to assist Vincentian citizens who were displaced as a result of the eruption, by providing daily meals. Four months later, WCK reached out to the government once more, this time to assist in the recovery phase, through its long-term resilience programme "The Food Producer Network" (FPN). The FPN's aim is to support smallholder farmers, fishers and food-related businesses through funding, training and network-ing opportunities, which will help them to revitalise their operations and recover their capacity for food production, distribution and sales after catastrophic events. FPN has assisted food producers in Puerto Rico, US Virgin Islands, The Bahamas and Guatemala following various national disasters.

On Tuesday, 17th August 2021, Mrs. Alexandra Garcia, Chief Programm Officer of World Central Kitchen and Ms. Mikol Hoffman, Director of FPN, met with Senator The Hon. Keisal Peters, Minister of State with Responsibility for Foreign Affairs and Foreign Trade and other Senior Officials from the Ministry of Foreign Affairs and Foreign Trade, the Ministry of Agriculture, Forestry and Fisheries, the Ministry of National Mobilisation, Social Development, Family, Gender Affairs, Persons with Disabilities and Youth, the Ministry of Education, National Reconciliation, Ecclesiastical Affairs and Information and, the National Emergency Management Organisation (NEMO) to discuss grants which are available to food producers in SVG.

The Government stakeholders would be working assiduously with the World Central Kitchen Officials so that SVG can be officially registered with the World Central Kitchen Regional Food Security Program Strategy and secure grants for farmers and business owners.

## SVG TO SHOWCASE AT EXPO 2020 DUBAI

For a period of six months, or until March 31, 2022, SVG will be among 190 countries showcasing various sectors of the Vincentian economy. St. Vincent and the Grenadines will be among 191 participating nations participants in Expo 2020 Dubai. Expo 2020 was initially scheduled to be hosted from 20 October 2020 – 10 April 2021. However, due to the COVID-19 pandemic in the United Arab Emirates, the new dates were listed as October 2021 – 31 March 2022.

Invest SVG is the entity charged with the responsibility of ensuring that this country's presence at Expo 2020 Dubai is impactful and has a significant outcome.

It is estimated that for the duration of Expo 2020 Dubai, some 25 million visitors will view the various pavilions on display, which provide the perfect opportunity for participating countries, including St Vincent and the Grenadines to showcase their destinations.

Permanent Secretary in the Ministry of Foreign Affairs and Foreign Trade, Mrs. Sandy Peters-Phillips stated that the event is expected to be a big one which will showcase a wide range of products from various sectors including culture, tourism and the arts and provide various displays for investment opportunities. PS, Peters-Phillips also highlighted that trade was an important catalyst to reengineer economic growth stating that "these occasions provide a platform to facilitate economic prosperity that is much needed at this time." Additionally, she contended that this country's national economic and social development plan recognises the need for an increase in the penetration of new markets as well as volumes or exports in order to achieve a strong sustainable trade arrangement. Therefore, successful participation in Expo Dubai can assist in accomplishing this objective resulting in an increase in export, and thereby enhancing national development."

The focal point of SVG's representation at Expo 2020 Dubai is not just going to be on establishing trade or investment arrangements, but to promote other aspects of the Vincentian way of life which include Vincy Mas, with the planned 2022 edition expected to be launched at Expo 2020 Dubai.

Ms. Annette Mark, Executive Director of Invest SVG remained confident that SVG IS an mazing product to showcase. Ms. Mark explained that though the effort is an expensive one, the work invest SVG has been doing will redound to success. The space dedicated to SVG at Expo 2020 Dubai is a total of two floors with over 2,000 square feet of space. Ms. Mark explained that the intention was to have the exhibits on the first floor and upstairs be reserved for offices, meetings or for facilitating members of the Vincentian team. And while Ms. Mark spoke of the opportunities of being a part of the Expo, she cautioned that it was important to bring those opportunities back to St. Vincent and the Grenadines and therefore, it was intended that the team will return with a large database.



St. Vincent and the Grenadines and the United Arab Emirates established diplomatic relations since 20<sup>th</sup> February, 2009. The bilateral cooperation between both countries has seen tremendous growth over the years. The UAE has been a cordial partner to SVG. Recently, there was a donation of 1333 packages of medical and food supplies to assist in the relief and recovery efforts, after the explosive eruptions of the La Soufriere volcano.
