<b>5.</b>	<b>ANDORRA (PRINCIPALITY OF)</b>	Business/Vacation – No Employment – No Other- No	<p>Andorra tourist visa is not required for citizens of Saint Vincent and the Grenadines for a stay up to 90 days.</p> <p>The Principality of Andorra is not a member of the Schengen Area. Access to the Principality is made through France or Spain. Thus, any national from a third-country travelling to Andorra must get information from the French or Spanish Embassies or Consulates (depending on the country of entrance) about the need of a Schengen visa, and when deemed necessary, about the visa obtaining procedures.</p> <p>When the Schengen visa is required, third-country nationals shall apply for a double-entry or a multiple entry Schengen visa depending on how many times you will enter the Schengen area from Andorra.</p>

If that is not the case, you need to renew it. Otherwise, your visa will be declined.</li> <li>• <b>Digital copy of your passport</b> – all you have to do is a scan so that you can submit.</li> <li>• <b>Means of payment</b> – when it comes to payment, you have multiple options. You can use a credit or debit card, but you can also use a Paypal account if you have one.</li> <li>• <b>A valid e-mail address</b> – the <u>Azerbaijan e-visa</u> will arrive via email in the timeframe you choose during the application process. That is why it is essential for your e-mail address to be spelled correctly.</li> </ul> <p>To attract more foreign tourists and to encourage them to plan their travel to Azerbaijan, Government of Azerbaijan has initiated e-Visa from 2016 and it was introduced for citizens of many countries. Besides that, Government of Azerbaijan implemented a modern electronic system for processing your Azerbaijan visa electronically at arrival ports.</p> <p><b>Visa Application Fees:</b> Payment is done through Paypal. - The couple must submit a passport-size photo of the wife.
- All documents must be sent to the Ministry of Foreign Affairs in Bahrain to for approval.
- Passport should be valid for six (6) months from arrival in Bahrain.
- A valid confirmed onward travel ticket to leave Bahrain.
- You must be capable of supporting yourself (and dependents if travelling with you) during the visit
- You must not violate the security and national welfare of Bahrain.
- You must use a visit eVisa within 30 days of its approval (after this time the eVisa will expire and you will have to apply again and pay another fee)

**Working Visas:**

- Work visas are issued based on the Non-Objection Certificate (N.O.C) issued by the General Directorate of Nationality, Passports and Residence in the Kingdom of Bahrain.
- Working Visas cannot be issued without taking prior approval from the Ministry of Foreign Affairs.

The eVisas are valid for two weeks, but can be extended on application. You can also get a longer three-month visa by applying on arrival in Bahrain.

3. Heads of State and Heads of Government
4. Visa exempt nationals coming to Canada as tourist.

Biometrics is required to be submitted to Canadian authorities once every ten (10) years by persons applying for the visa.
