Antigua and Barbuda

- **Number of persons to be accepted:** 250 persons
- **Accommodation:** Jolly Beach Hotel
- **Provisions:** Covered by Antiguan government
- **Transportation:** To Be Announced
- **COVID-19 Requirements:**
 - Negative COVID-19 test result from Saint Vincent prior to leaving.
 - PCR COVID-19 test will be administered on arrival.
 - Complete a medical form on arrival.
 - All persons must quarantine.
 - Vaccination not mandatory.

Persons have the option to connect with families and integrate in society as desired after the quarantine period.

INFORMATION FOR OVERSEAS DISPLACEMENT TO NEIGHBORING COUNTRIES

Commonwealth of Dominica

- **Number of persons to be accepted:** 300 persons for 5 months
- **Accommodation:** Moroccan Hotel, private apartments and homes
- **Provisions:** Covered through Dominican private sector sponsorship
- **Transportation:** To Be Announced
- **Required Documents:**
 - Valid Government-Issued ID: ID, Driver's License or Passport
 - Birth Certificate
 - Medical records where available
- **COVID-19 Requirements:**
 - PCR COVID-19 test will be administered on arrival.
 - Quarantine for 14 days, with daily screenings.
 - Vaccination not mandatory. Provision will be made to receive second dose in Dominica for those who have gotten first dose. Please bring along the COVID-19 inoculation card accordingly.

Persons will have the option to connect with families or friends and integrate in society as desired after the quarantine period.

Saint Kitts and Nevis

- **Number of persons to be accepted:** St. Kitts: 200, Nevis: 100, 6 months
- **Accommodation:**
 - Marriott Hotel: 70
 - Mt. St. Nevis Resort: 30
 - Private apartments and homes: 200
- **Transportation:** TBA
- **Provisions:** The Government of St. Kitts & Nevis will provide welfare support including psychological assistance, as necessary.
- **COVID-19 Requirements:**
 - Negative COVID-19 test result from Saint Vincent on arrival
 - Must quarantine for 14 days, with COVID-19 test screening.
 - Vaccination not mandatory. Provision will be made to receive second dose in Saint Kitts and Nevis for those who have gotten first dose. Please bring along the COVID-19 inoculation card accordingly.

Persons have the option to connect with families or friends and integrate in society as desired after the quarantine period.

INFORMATION FOR OVERSEAS DISPLACEMENT TO NEIGHBORING COUNTRIES

Saint Lucia

- **Number of Persons to be accepted:** 80 persons in the first instance. Total to be determined.
- **Accommodation:** Starfish Quarantine Facility followed by private homes certified by the Government of Saint Lucia
- **Transportation Arrangements:** To Be Announced
- **Required documents:**
 - Driver's license, National ID card or passport
 - Persons are encouraged to provide immunization records or medical records so that they can benefit optimally from health services.
- **COVID-19 Requirements:**
 - COVID-19 tests will be done on arrival.
 - Must complete 3-5 days quarantine period at the state's "Starfish" facility.
 - Vaccination not required. Provision will be made to receive second dose of vaccine in Saint Lucia for those with inoculation card.
