# SAINT VINCENT AND THE GRENADINES HOSTS ITS FIRST NATIONAL COORDINATORS MEETING VIRTUALLY IN ITS CAPACITY AS THE PROTEMPORE PRESIDENT OF THE COMMUNITY OF LATIN AMERICAN AND CARIBBEAN STATES (CELAC)

These meetings coordinate dialogue and political consensus at the national level, facilitate regional integration, monitor cooperation on projects within organisation, organise, coordinate and observe working function groups, a s the preparatory body for meetings of Ministers of Foreign Affairs, and report the findings working groups tο the Ministers.

National Coordinators serve as a link between Member States and the Pro-Tempore Secretariat by and directly coordinating monitoring topics under discussion, and meet twice yearly before the Meeting of Foreign Ministers. Each country assigned one National Coordinator and one Alternate or Deputy National Coordinator.

The first National Coordinators Meeting recorded participation from twenty-two Member States of CELAC, where a comprehensive work plan to guide the activities and initiatives for the year was presented by His Excellency Andreas Wickham,

Deputy National Coordinator of Saint Vincent and the Grenadines to CELAC and deliberated by the CELAC membership.


The agenda of the National Coordinators' meeting included a briefing to the CELAC Membership by Excellency, Dr. Douglas Slater o n the upcoming CELAC- EU Summit which is scheduled to convene in Brussels on July 17-18, 2023. This is the first CELAC-EU Summit within five years and will be co-chaired by Dr. The Ε. Honourable Ralph Gonsalves in his capacity as the Pro-Tempore President of CELAC and His Excellency Charles Michel, the President of European Council.

St. Vincent and the Grenadines successfully completed its fourth Trade Policy Review (TPR) as part of the country's obligations as a Member of the World Trade Organisation (WTO) in Geneva on the 3rd and 5th of May 2023.

The main purpose of the Trade Policy Review Mechanism is to improve adherence by all WTO members to rules.

disciplines and commitments made under the multilateral trade agreements and where applicable the plurilateral agreements. SVG's fourth TPR focused on the macroeconomic and trade performances, trade and investment patterns, trade policy initiatives and trading arrangements.

# THE GOVERNMENTS OF SAINT VINCENT AND THE GRENADINES AND THE REPUBLIC OF SIERRA LEONE ESTABLISHEED DIPLOMATIC RELATIONS

The Governments of Saint Vincent and the Grenadines and The Republic of Sierra Leone have officially established diplomatic relations as of April 12, 2023.

A Joint Communique signaling the establishment o f diplomatic relations was signed by the Government of Saint Vincent and Grenadines represented bу H.E. Ms. Inga Rhonda King, Ambassador Extraordinary and Plenipotentiary and Permanent Representative of Saint Vincent and the Grenadines to the United Nations and the Government of the Republic of Sierra Leone represented by H.E. Mr. Alhaji Fanday Turay, Ambassador Extraordinary and Plenipotentiary and Permanent Representative of the Republic of Sierra Leone to the United Nations.

Diplomatic relations between both countries is guided by the terms of the Vienna

Convention on Diplomatic Relations of April 18, 1961. The Vienna Convention on Consular Relations of April 24, 1963, and the Charter of the United Nations.

The establishment of relations holds further significance as Sierra Leone celebrates its independence today, April 27, 2023. The Government and People of Saint Vincent and the Grenadines congratulates the Government and People of the Republic of Sierra Leone on the occasion of their 62nd anniversary as an independent nation.



#### SVG DONATES PAINTING TO DAS

The Permanent Mission of Saint Vincent and the Grenadines to the Organization of American States (OAS) donated a painting 'The Prayers of Spring' to the Art Museum of the Americas, in Washington, D.C, United States of America, on behalf of the Government and people of Saint Vincent and the Grenadines. Ambassador and Permanent Representative to the OAS, H.E. Louanne Gilchrist, handed over the painting on Friday, March 31st, 2023, to the Secretary General of the OAS, H.E. Luis Almagro.



The piece, aptly titled "The Prayers of Spring", represents a beacon of the coming of spring, the season of new life, fruitfulness, hope and faith in God, according to the artist, Mr. Calvert Jones. The painting features the Poui tree in full bloom outside the historic St. George's Cathedral in Kingstown and is an outstanding work from the artist's portfolio, in his own Tropical Realism style. It will form part of the permanent collection of the Art Museum of the Americas.



The painting contains ash from the La Soufrière volcano that erupted in April 2021, and, according to Ambassador Gilchrist," is a representation of the vulnerability of our island and the embodiment of the resilience of our people." Mr. Jones, in his note to the audience, explained that "shortly after the eruptions began, the Poui trees were seen bursting with glory against the gray, gloomy drenching of volcanic ash." The painting has therefore captured the hope and optimism of Vincentians which will now be on permanent display.



The donation occurred just over two weeks after our nation celebrated its National Heroes' Day on March 14th, honouring Paramount Chief His Excellency Joseph Chatoyer and on the last day of our symbolic heritage month. Ambassador Gilchrist noted that the donation is an important step in strengthening cultural diplomacy and in promoting understanding, appreciation, tolerance and respect for others.



Secretary General Luis Almagro thanked the Permanent Mission for the gift and reinforced the importance of cultural diplomacy the importance of the representation of the CARICOM States, as the region prepares to celebrate its 50th anniversary.
